

RULES

Art. 1 – The Cultural Centre for musical studies "Giovanni Colafemmina", with the sponsorship and the contribution of the municipality of Acquaviva delle Fonti, of the Apulia region, of the province of Bari, of the Lions Club of Acquaviva delle Fonti, of the musical Lyceum "Don Lorenzo Milani", Acquaviva delle Fonti 's Pro Loco index and organizes the **The International Piano Competition "Città di Acquaviva delle Fonti"- "Giovanni Colafemmina" prize** In order to promote the musical culture by encouraging and rewarding the study of the piano.

Art. 2 – The competition is aimed at pianists of all nationalities without age limits. The competition will take place from 24th to 27th October 2012 at the Hall Ala Nord Palace De Mari and the Auditorium of Liceo musical "Don Lorenzo Milani" sites in Acquaviva delle Fonti (Bari-Italy).

Art. 3 – The tests will be public and obligatory by heart.

Art. 4 – The order of call of the candidates will be established to draw for order of call from the artistic direction ten days before the competition and will be valid for all the tests. Study pianos will be available to the candidates.

Art. 5 – The jury decrees the prizes. The first prize is indivisible, the other prizes can also be awarded ex-tie by dividing the scholarship. The contestants will support three Tests, no song is allowed to repeat. The members of the jury cannot present their students in the competition.

Art. 6 – At the beginning of each hearing, competitors must submit to the examining board:

1. Identity document
2. Two copies of the songs scheduled.

Art. 7 – The Proclamation and award ceremony of the winners will take place in official form on Saturday 27th October 2012 at the end of the round final round with the Orchestra.

Art. 8 – In the preliminary round phase the jury vote will be expressed with Yes or NO. In the round semifinal round and final round The vote will be expressed in hundredths and access the final round with the Orchestra, the three contestants who have obtained the highest score. The jury's judgement is final.

Art. 9 – The application form to the competition implies acceptance of all the rules included in this rules. In case of dispute the text drawn up in ITALIAN will be worth.

Art. 10 – The application form shall be carried out no later than 30 September 2012:
